# **Section A**

#### **Section B**

4 Malik collects and restores old cars which he keeps in his back garden. He has drained the fuel tanks and stores the petrol in cans next to the cars. While Malik is out, some local children enter the garden to play. They knock over the petrol cans and all the petrol leaks out into the neighbouring gardens. That evening, Malik's next door neighbour, John, decides to have a barbeque in his back garden. He lights the barbeque and the leaked petrol ignites. The resulting fire causes extensive damage to a number of houses on the street.

Advise Malik as to his potential liability in this situation.

5 James is a learner driver. While on a driving lesson with his instructor, Ali, he takes a corner too fast and crashes into an oncoming vehicle. Ali suffers concussion and a broken leg.

The driver of the other vehicle, Kathy, is badly injured and is taken to hospital. Kathy's mother, Celine, receives a phone call to tell her about the crash. She rushes to the hospital and sees her daughter as she is brought in for treatment. Although Kathy makes a full recovery, Celine is still feeling upset and has taken a lot of time off work. Ali is suffering from depression following the incident and has been unable to work.

Advise James, Ali, Kathy and Celine as to their potential rights and liabilities in this situation. [25]

Patrick and Bridget are staying at The ABC Hotel. On returning very late one evening they realise that they have left the key in their hotel room. The front door is locked and so they decide to climb up to the balcony of their room on the first floor. Patrick finds a ladder which has been left behind by a builder who is working at the hotel. Bridget holds the ladder as Patrick climbs up. As Patrick steps off the ladder on to the balcony, a railing that he is holding breaks away and he falls to the ground. He suffers serious injury in the fall. Bridget is injured when she is hit by the falling railing.

Advise Patrick and Bridget as to the likely success of an action against The ABC Hotel. [25]
